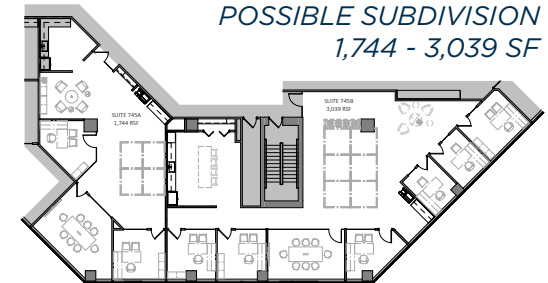


SUITE 745 - SPEC SUITE 4,783 SF (DIVISIBLE TO 1,744 SF)

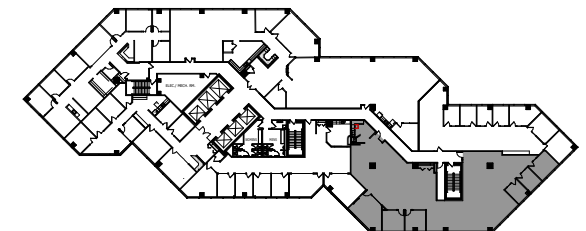
